APPLICATION FOR SIGNAGE PLAN REVIEW (2 Sets Required)

1. Signs must comply with OBC 3107 and NEC 600.
 2. Exterior signage which is supported by, attached to, or projecting from a building, i.e. wall signs, roof signs, blade signs, etc., require a plan review and permits.
 3. Ground signs not over 6 feet in height above the adjacent grade do *not* require a plan review or permits, except illuminated ground or pole signs require an electrical permit only
 4. All submissions that require plan review require a completed application form, appropriate fees and two sets of drawings*.
 5. All submissions that require plan review require the owner's written consent to construct the signage on the property.

Exterior Signage - Plan Review and Permits

Exterior signage which is supported by, attached to, or projecting from a building, i.e. wall signs, roof signs, blade signs, etc. require a plan review and permits. See *Submittal Checklist below*.

Ground signs not over 6 feet in height above the adjacent grade do *not* require a plan review or permits, except illuminated ground or pole signs require an electrical permit only.

Signage - Submittal Checklist

All submissions that require plan review require a completed application form, appropriate fees and two sets of drawings*. This checklist is a guide and is not all inclusive. Signs must comply with OBC 3107 and NEC 600. Contact the Building Department if you need assistance or clarification.

- ___ 1. Submit a copy of the owner's or lessee's written consent to construct the signage on the property.
- ___ 2. Submit two copies of construction documents including:
 - ___ a. Site plan showing the building location on the site and the location of each sign on the building. (A drawing or an aerial photo is acceptable.) Identify each sign as #1, #2, #3, or A, B, C, etc. on site plan, elevations, sections, etc.
 - ___ b. Elevations of each sign showing size of sign and height above grade. (A drawing or a photo with superimposed image of sign is acceptable.)
 - ___ c. Cross sections of each sign identifying materials and method of attachment to building, including size, type and spacing of anchors.
 - ___ d. Registered Design Professional may be required for certain non-typical signs. (roof signs, marquees, large signs, signs installed higher than 30' above grade, etc.)
 - ___ e. For illuminated signs:
 - i. An Electrical Permit is required for illuminated signs, unless the sign is a replacement sign *and* the existing circuit and wiring will be used *and* no other electrical work will be performed.
 - ii. Each sign must be UL listed. (Or other NRTL).
