On or about 5/28/2025 the County of Summit will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of Older Adult Home Modification Program funds under the Consolidated Appropriations Act, as amended, to undertake the following multi-year program/project: OAHMP, for the purpose of providing low-cost, low-barrier, high-impact home modifications for income-qualified seniors that reside within the County of Summit to facilitate aging in place, safety, and accessibility concerns. Should individual aggregate projects exceed the threshold for categorical exclusion detailed at §58.35(a), an Environmental Assessment will be completed and a separate Finding of No Significant Impact and Request for Release of Funds published. RELEASE OF FUNDS

The **County of Summit** certifies to HUD that **Executive Ilene Shapiro** in **her** official capacity as **Summit County Executive** consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that

these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the **County of Summit** to utilize federal funds and implement the Program.

OBJECTIONS TO RELEASE OF FUNDS

HUD will consider objections to its release of funds and the **County of Summit** certification for a period of fifteen days following either the anticipated submission date (cited above) or HUD's actual receipt of the request (whichever is later) only if the objections are on one of the following bases: (a) that the Certification was not executed by the Certifying Officer of the **County of Summit**; (b) the **County of Summit** has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the **County of Summit** has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.
