

## **DIRECTIVE NO. IT 2025-03**

**Authorizing the Executive to execute a contract renewal with AdvizeX Technologies, LLC., as Best Practical Source, for PureStorage Solution for SAN, for a one-year term, from 5/1/2025 to 4/30/2026, in an amount not to exceed \$104,580.00, for the Office of Information Technology.**

**WHEREAS**, AdvizeX was selected to replace the previous Information Technology storage system that went out of support in October of 2023 and to provide additional storage functionality and flexibility to increase storage with only additional subscription costs and no additional hardware; and

**WHEREAS**, the County wishes to renew its contract with AdvizeX Technologies, LLC., as Best Practical Source, for PureStorage Solution for SAN, in an amount not to exceed \$104,580.00; and

**WHEREAS**, pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit, AdvizeX Technologies, LLC. is a Best Practical Source as they currently provide the referenced service; and

**WHEREAS**, the County of Summit Information Technology Board finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a contract renewal with AdvizeX Technologies, LLC., as Best Practical Source, for PureStorage Solution for SAN, for a one-year term, from 5/1/2025 to 4/30/2026, in an amount not to exceed \$104,580.00;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Trustees of the County of Summit Information Technology Board that:

### **SECTION 1**

The County Executive is hereby authorized to execute a contract renewal with AdvizeX Technologies, LLC., as Best Practical Source, for PureStorage Solution for SAN, for a one-year term, from 5/1/2025 to 4/30/2026, in an amount not to exceed \$104,580.00.

### **SECTION 2**

It is found and determined that all formal actions of the Board concerning and relating to the adoption of this Directive were taken in an open meeting of the Board, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law, including Section 121.22 of the Ohio Revised Code.

### SECTION 3

This Directive shall take effect immediately upon its adoption.
