Authorizing the Executive to execute a contract with Adgators, LLC., for digital signage and wayfinding for the Summit County Courthouse, for a one-year term, from 1/10/2025 to 1/9/2026, in an amount not to exceed \$87,344.00, for the Office of Information Technology.

WHEREAS, the Ohio Supreme Court awarded a Technology Grant to the County of Sumit, in the amount of \$75,616.00, with no local cash match requirement, for digital signage and wayfinding for the Summit County Courthouse and

WHEREAS, the County wishes to enter into a contract with Adgators, LLC., as Best Practical Source, for digital signage and wayfinding for the Summit County Courthouse, for a one-year term, from 1/10/2025 to 1/9/2026, in an amount not to exceed \$87,344.00; and

WHEREAS, this contract with Adgators, LLC. is exempt from competitive bidding as a grant contract and pursuant to Section 177.07(a)(12) of the Codified Ordinances of the County of Summit; and

WHEREAS, the County of Summit Information Technology Board finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a contract with Adgators, LLC., for digital signage and wayfinding for the Summit County Courthouse, for a one-year term, from 1/10/2025 to 1/9/2026, in an amount not to exceed \$87,344.00;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the County of Summit Information Technology Board that:

SECTION 1

The County Executive is hereby authorized to execute a contract with Adgators, LLC., for digital signage and wayfinding for the Summit County Courthouse, for a one-year term, from 1/10/2025 to 1/9/2026, in an amount not to exceed \$87,344.00.

SECTION 2
