

DIRECTIVE NO. IT 2025-02

Authorizing the Executive to execute a contract with Axon Enterprise, Inc. at State Term Pricing, for the implementation of and subscription to Axon Evidence, Evidence.com, and Axon Storage, for a ten-year term, from 12/31/2024 to 12/31/2034, in an amount not to exceed \$151,963.60 per year, for a total amount not to exceed \$1,519,636.00, for the Prosecutor and the Office of Information Technology.

WHEREAS, Axon Evidence, Evidence.com, and Axon Storage are used by law enforcement agencies including the Summit County Sheriff's Office, Akron Police Department, Barberton Police Department, and others that allows evidence sharing between agencies, secure storage, and video support; and

WHEREAS, the County wishes to enter into a contract with Axon Enterprise, Inc. at State Term Pricing, for the implementation of and subscription to Axon Evidence, Evidence.com, and Axon Storage, for a ten-year term, from 12/31/2024 to 12/31/2034, in an amount not to exceed \$151,963.60 per year, for a total amount not to exceed \$1,519,636.00; and

WHEREAS, this purchase contract provides a discounted savings of \$129,375.60 per year for a total savings of \$1,293,756.00 over the ten-year term; and

WHEREAS, the County of Summit Information Technology Board finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a contract with Axon Enterprise, Inc. at State Term Pricing, for the implementation of and subscription to Axon Evidence, Evidence.com, and Axon Storage, for a ten-year term, from 12/31/2024 to 12/31/2034, in an amount not to exceed \$151,963.60 per year, for a total amount not to exceed \$1,519,636.00;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the County of Summit Information Technology Board that:

SECTION 1

The County Executive is hereby authorized to execute a contract with Axon Enterprise, Inc. at State Term Pricing, for the implementation of and subscription to Axon Evidence, Evidence.com, and Axon Storage, for a ten-year term, from 12/31/2024 to 12/31/2034, in an amount not to exceed \$151,963.60 per year, for a total amount not to exceed \$1,519,636.00.

SECTION 2

It is found and determined that all formal actions of the Board concerning and relating to the adoption of this Directive were taken in an open meeting of the Board, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law, including Section 121.22 of the Ohio Revised Code.

SECTION 3

This Directive shall take effect immediately upon its adoption.


