June 17, 2021

The meeting of the Summit County Emergency Management Executive Committee (EMEC) was called to order on Thursday, June 17, 2021, at 10:02 AM via Zoom by Bill Holland.

Chief Funai discussed the updated Mass Casualty Incident (MCI) Plan and the incorporation of pediatric patients. There was an update from the Assistant Secretary of Preparedness and Response (ASPR) that challenged the traditional MCI. The updated MCI plan incorporates law enforcement, EMA, and dispatch for gathering and resourcing information. It eliminates the idea of the coordinating hospital and moves away from the traditional triage tags. The overall scene may incorporate a 2nd triage area. The MCI is not over until all patients receive definitive care.

Mark Derrig made a motion to send these additional annexes to the State for approval with Heidi Swindell as the second. The motion was moved by voice vote.

 - **FY18 SHSP Grant Update:**
 - All projects are complete, the last grant m & a reimbursement request must be submitted by June 30, 2021.

 - **FY19 SHSP Grant Update:**
 - 19 total projects; 11 complete, 6 equipment projects have been ordered, 2-bid advertisements in the process and/or obtaining a purchase order from BOC. The supply chain has drastically been affected by covid and we are starting to see equipment delays. We have had to restart the procurement process for several projects, due to equipment delays. A grant extension may be needed.

 - **FY20 SHSP Grant Update:**
 - Started writing specs for all projects to send to OEMA for approval before procuring any projects.

 - **FY20 PUCO Grant Update: -**
 - All documents have been submitted for reimbursement.

 - **FY21 Search and Rescue Grant Update:**
 - Both grants are complete and all final reporting has been completed and submitted to OEMA.

Summit County Public Health

Donna Skoda reported they have stopped monitoring any flu disease at this stop and time. Summit County had very little flu (3 reported). We could have a record mosquito and tick season because of the wet weather. The COVID numbers are coming down but they still have some people who are vaccinated with some breakthrough with the disease. In Summit County, there was a 51% vaccination rate. They are making a targeted effort to reach the younger community. We are doing 20-30 community vaccination events a week, averaging 110 people. Donna also discussed masking.

800 MHz Radio System Report

- Macedonia PD, Northfield Village PD, and Hudson FD deployed new radios since the last meeting – All 31 communities are now on the radio system
- Summa PD adding (73) radios and using system full time starting July 1st
- Cleveland Clinic AGMC PD is expected to be a radio system user in 2021
- Performing software updated on the radio system Tuesday
- Discussed Link Layer Authentication – two-factor authentication for radios that will be required by July 2025
