 - State-Funded Mitigation Program
 - It has been a goal in the State of Ohio Hazard Mitigation Plan for many years to develop a state-funded mitigation grant program.
 - The proposal made it into the Governor's budget and will be considered by the state legislature this spring.
 - FEMA has shifted the priorities for the federal mitigation grant programs. Creating a state mitigation grant program will allow Ohio to implement projects we have traditionally funded and identified in local hazard mitigation plans.
 - Discussion on the TACS
 - Reorganizing/charters are being updated
 - Hazmat- released list of validated teams throughout the state
 - SAR- being rebuilt, RTF reorganization
 - Water- updating
 - New TACs

 - Solar Eclipse
 - There is a potential to receive reimbursement for emergency response.

 - o Small Business Administration Reform
 - SBA is revising its approach to providing disaster assistance, including expediting timeframes and increasing the number of eligible losses a disaster survivor can borrow.

- Elected and Senior Officials CISA Cybersecurity Training April 20. Great attendance and overview
- We will host an NTSB for a Family Assistance Center Workshop on September 26-27 to share what resources are available with the Family Resource Center.
- Tim Gemind reported on the following:
 - AFD Lt. Dave Tenney promoted to Water Rescue Deputy Director
 - Technical Rescue Incident to Warren Township in Trumbull County.
 - A tree fell on the house, with a person trapped; the individual was removed before our arrival.
 - Monthly training ongoing for all branches
 - Technical Rescue and Water Rescue joint Swift water refresher training in the Cuyahoga River was a big success earlier this month.
 - Discussions taking place about adding a Drone Branch to SCSORT

- Angela Robinson reported the following:
 - FY23 SHSP Tommy emailed an announcement on April 7 with a 4/24/23 deadline. We applied for six applications with a value of approximately \$1.1 million
 - o FY22 SHSP- 8 projects awarded totaling \$636,612.00 are still on hold.
 - FY21 SHSP- 9 projects, four complete and five in progress. We are working with OEMA to get approval to expend the remaining grant funds.
 - FY20 SHSP- Completed 16/16 projects. The performance period ended on 3/31/23
 - FY23 SAR Stipend (\$9,334) and FY23 SAR- Water (\$8,083.00). Everything
 has been ordered, but there are supply chain issues. We did request a grant
 extension for both grants and were granted until 7/31/23 to complete.
 - FY22 Public Utilities Commission of Ohio (PUCO Grant)- for three specialized hazmat training. The team completed all three trainings as of last week. Angela is in the process of completing the paperwork for reimbursement.
 - FY22-24 HMEP Grant- these trainings are in May, June, and August. We were awarded \$55,050, 80% reimbursable, and 20% cost share. The performance period ends on 9/29/23.
 - FY22-24 HMEP Year 2 The grant application was submitted on 3/9/23 for four specialized hazmat trainings that will help with identification, staging, mass care, evacuation and re-entry, and decontamination in case of a train derailment. 80%, 20% 52,950.00 total. 42,360.00 80%-reimbursement and 20% \$10,590.00.
 - FY22 Hazard Mitigation Planning Grant to update the Hazard Mitigation Plant Grant. I am working diligently with Tommy and Joseph to gather information for grant reporting and reimbursement requests. Award adjustments have been made based on the total cost of the project- The grant award is \$21,670.00; \$19,503.00 reimbursable with a local match of \$2,167.00. The first drawn-down request has been reimbursed.
 - o FY21 EMPG- completed grant total award amount of \$227,632.00.
 - FY21 EMPG- ARPA \$73,650.00 Award- Cash request is pending with OEMA.
 The grant will be completed once reimbursement is made.
 - FY21 EMPG Supplemental- OEMA approached an opportunity to receive EMPG remaining funds. We could apply because we effectively used all FY21 EMPG regular and ARPA. We had around \$42,000.00 in expenses; we will receive a 50% reimbursement if approved.
 - FY22 EMPG- Award amount is \$437,672.00- 50% reimbursable. Grant assurances, grant agreement, and misc. documents have been submitted to OEMA.
 - Quarterly reporting for the period ending 3.31.23 has been submitted to OEMA.
 - EMPG Cash Supplemental Request for the period ending 3.31.23 has been submitted to OEMA.
 - Completed OEMA trainings, OH 318 Mitigation Planning and G358 Evacuation and Re-entry

- We have been asked to participate in this year's Copley Safety Town; Maggie Surber will represent our office, and she will debut the new Safety Town video will be shown.
