County to Hold "Can Do!" Dog Licensing Program at Five Acme Fresh Market Locations on Saturday, June 24th

**DATE:** June 13, 2017

On Saturday, June 24, 2017, Summit County Executive Ilene Shapiro and Summit County Fiscal Officer Kristen Scalise will partner with Acme Fresh Markets to host "Can Do!" – a one-day event to provide amnesty to Summit County dog owners who have not yet purchased their 2017 dog licenses. During the event, dog owners who failed to renew their dog's license will have their \$18 late-fee waived by donating a can of dog food to the Summit County Division of Animal Control.

From 10 a.m.-2 p.m., dog owners can take advantage of the Can Do! program at the following Acme Fresh Market stores: Acme #1- 1835 W. Market St., State Road Acme- 2226 State Rd., Tallmadge Acme- 600 South Ave., Stow Acme- 4445 Kent Rd., and Portage Lakes Acme- 3235 Manchester Rd. Dog owners wishing to participate in the event should bring cash or check in the amount of \$18.00 for the license fee, and at least one can of dog food in lieu of the additional \$18.00 late fee. Owners with multiple dogs should bring the license fee and a can of dog food for each unlicensed dog.

"In the event a beloved dog is lost or injured away from its home, maintaining a license is vital for ensuring

its safe return to its owner" said Executive Shapiro. "The Can Do! event is a wonderful opportunity for pet

owners to renew their licenses and donate food to Summit County's shelter animals in lieu of paying a late fee.

Thanks to ACME Fresh Market's willingness to partner with the County, we are able to ensure that the pets at

the animal shelter are properly fed while awaiting redemption by their owner or adoption."

The Ohio Revised Code and Summit County Ordinances require citizens who own, keep or harbor a dog more

than three months of age to purchase a county dog license on an annual basis. In addition to complying with

the law, county-issued dog licenses provide legal proof of ownership and identification if a pet is lost.

"Maintaining a current dog license is important for your pet's safety and well-being" said Fiscal Officer

Scalise CPA, CFE. "The Can Do! event provides a great opportunity to get a 2017 dog license if you forgot

to purchase one during the annual renewal period."

The Summit County Division of Animal Control Facility, located at 250 Opportunity Parkway in Akron, offers

affordable and unique adoption opportunities. The cost to adopt a dog is \$94, while the cost to adopt a cat is

\$60. Adoption fees include blood work, flea treatments, intestinal de-worming, a license (if necessary), a

spay/neuter operation, and vaccinations.
